FINAL ORDER

Sh. P. C. Malhotra R/o Site-II/158, Janta Flat, Vikas Puri, New Delhi-110018 has applied before this Tribunal vide registration no. 60 (4459) dated 19/08/2014 complaining against his son Sh. Anshu Malhotra residing on above mentioned address under section 5 of the Maintenance & Welfare of Parents & Senior Citizens Act, 2007.

Case called. Present Sh. P. C. Malhotra, petitioner, 71 years old and complaining about the intimidating, abusive, threatening behavior verbal as well physical through his son Sh. Anshu Malhotra (Respondent) who is forcefully residing in his house. The petitioner is claiming maintenance for his old age medical problems and household expenses from the respondent till he vacate the house. Due to old age medical problems, petitioner was not willing to visit in the court again.

The Respondent, Sh. Anshu Malhotra, has not appeared before the court while the show cause notices personally received by Smt. Rajni Malhotra W/o Sh. Anshu Malhotra in the presence of petitioner Sh. P.C. Malhotra.

After going through the facts, Tribunal declared respondent sh. Anshu Malhotra as ex party and Final Orders as follows:-

1. Maintenance amount of Rs. 10,000/- per month shall be paid by the Respondent Sh. Anshu Malhotra to the Petitioner by cheque in the account of the petitioner by 10th of every month as against rent, food and medical care and look after of petitioner.
2. The concerned SHO, Moti Nagar to keep a vigil over the life and property of Senior Citizen.
3. All parties are advised to improve their interpersonal relationship and live peacefully among themselves.
