
Case called the senior citizen Sh. Harmahender Singh, whose source of income only old aged pension. complaining about the abusive, threatful, intimidating behavior on part of his daughter-in-law Smt. Simran (Gudia) further claiming maintenance from the respondents.

After going through the observation and documentary evidences, Final Orders of the Tribunal are as follows:-

1. The respondents Sh. Bhupender Singh and Smt. Simran shall pay maintenance amount of Rs. 2000/- per month and Rs. 3000/- per month respectively into the bank account of the petitioner Sh. Harmahender Singh by cheque till upto the 10<sup>th</sup> of every month.
2. All the parties are directed to pay their utility bills separately.
3. The concerned SHO, Nihal Vihal shall keep a vigil over the life and property of the Senior Citizen.
4. All the parties are advised to improve their interpersonal relationship and live peacefully among themselves.
