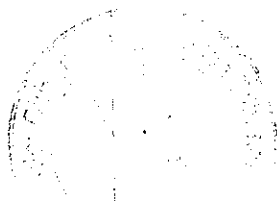
**FINAL ORDER**

Smt. Meera Devi R/o B-468-469, Hastal Road, Uttam nagar, J. J. Colony, Shani Bazar Road, New Delhi-110059 has applied before this Tribunal vide registration no. 37 (3228) dated 24/06/2014 complaining against her sons Sh. Vijay Kumar, Shiv Kumar and Sh. Govind under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007.

Case called. Smt. Meera Devi, Petitioner claimed maintenance from all the respondents. The respondent Sh. Shiv Kumar has agreed to vacate the house but he was not interested to pay the maintenance amount of his responsibility.

Conciliation efforts were made. On the basis of submissions and records, the Tribunal decides to pass Final Orders as follows:-
