FINAL ORDER

Sh. Bahadur Singh R/o A-4, Gali No. 2, Khasra No. 28/9, Hamgiri Enclave Extn., Chander Vihar, New Delhi-110041 has applied before this Tribunal vide registration no. 41 (3452) dated 07/07/2014 complaining against his sons Sh. Taranjeet Singh and Sh. Jaswinder Singh and daughter-in-laws Smt. Raman Deep Kaur and Smt. Charanjeet Kaur respectively under section 5 of the Maintenance & Welfare of Parents & Senior Citizens Act, 2007.

Case called. Present Sh. Bahadur Singh, petitioner alongwith his wife Smt. Balvinder Kaur and stated that they are forced to live with their daughter and son-in-law inspite of having their own house due to the abusive, threatening behavior of respondents (i.e. Sh. Taranjeet Singh, Sh. Jaswinder Singh, Smt. Raman Deep Kaur and Smt. Charanjeet Kaur) and tries to implicate the petitioner in the false cases. Further the petitioner prayed for eviction of respondents from

property no. WZ-60, Gali No. 32, Sant Garh, Tilak Nagar, New Delhi-110018 and also claim maintenance from the respondents till vacate the house.

After going through the observation and documentary evidences, the Tribunal decides to pass Final Orders as follows:-

1. All the respondents' sons (Sh. Taranjeet Singh, Sh. Jaswinder Singh and Sh. Jernail Singh) shall pay Rs. 3000/- per month each to the petitioner through cheque by 10th of every month into the account of the Senior Citizens.
2. Under the supervision of SHO, Tilak Nagar to assist the petitioner Sh. Bahadur Singh and his wife to move into the property no. WZ-60, Gali No. 32, Sant Garh, Tilak Nagar, New Delhi-110018 and confirm action taken.
3. The concerned SHO, Nangloi keeps a vigil over the life and property of Senior Citizen.
4. All parties are advised to improve their interpersonal relationship and live peacefully among themselves.
