
FINAL ORDER


Conciliation efforts after hearing the allegations and counter allegations, observations, and documentary evidences, the Tribunal decides to issue Final Orders as follows:-




1. The Respondent Sh. Alisan Buniyadi and Sh. Sameer Bunker shall pay a monthly maintenance amount of Rs. 3000/- per month and Rs. 2000/- per month respectively into account of the petitioner Smt. Shahida Ansari by cheque before the 10th of each month.
2. The electricity bill to be pay in proportion of 50-50% by the petitioner Smt. Shahida Ansari and the respondent Sh. Alisan Buniyadi.
3. Relative of respondent Smt. Monika Yadav shall refrain from entering the property no. A-567, Camp No. 2, Nangloi, New Delhi-110041
4. All parties are advised to improve their interpersonal relationship and refrain from abusive/complaining behavior.
5. The concerned SHO, Nangloi is advised to keep vigil over the life and property of the Senior Citizen.
